This program was designed and implemented to assist in meeting the mooring needs of the year- round residents and seasonal residents who wish to have access to Mattanawcook Lake and the downtown retail district.

What does this sticker allow me to do?

This permit will allow night-time mooring at the gazebo dock system. Two slips are available for seasonal rental. Permits will be offered to winners of a random drawing of applications received no later than April 1st, and winners will have two (2) weeks to pay for their permit or forfeit the opportunity to obtain a permit for the season. Permits available after April 17th can be purchased on a first-come first-served basis. A recipient of a docking permit will receive a sticker with the expiration date of the permit. If a boat is found to be utilizing overnight mooring without a valid sticker they will be subject to an illegal parking ticket administered by the Lincoln Police Department, the Lincoln Code Enforcement Officer, and/or the Cemetery, Parks and Recreation Director. Seasonal rate is \$500.00 and covers a period no longer than from May 1st through Indigenous Peoples' Day. See complete ordinance for more details.

- 1. A valid boat registration must be provided.
2. Sticker must be affixed to the watercraft in a visible location.
3. If you vacate your rented slip before the end of the season, you are encouraged to notify the Lincoln Town Office and to allow them to make an additional permit available for another boat to utilize the slip.

IF THE STICKER IS NOT VISIBLE, YOU ARE SUBJECT TO A PARKING TICKET.

No person shall furnish any false information to the Town of Lincoln in connection with obtaining any permit, or said permit shall become null and void. The Town of Lincoln assumes no liability for the loss of items on or stored in the boat or damage to the boat itself caused by theft, weather, and or vandalism.
